In case where the marks obtained by two or more candidates are equal, the rank among them is decided based on the date of birth.
- b) Any claims preferred by the candidates should reach within 10 days from the date of issue of this notification, and appeals received after 10 days will not be entertained.
- c) The differently Abled candidates shall fulfill the norms as per G.O.(Ms).No.13, Welfare of Differently Abled Persons (DAP.3.2) Department, dated 02.03.2016.
- d) The reservation to the posts have been done as per the 200 point roster issued in G.O.Ms.No.55, P&AR Dept. Dated 08.04.2010 and duly taking into consideration of all subsequent instructions of the Government in this regard.
- e) The provisional selection is purely provisional. The provisional selection and consequent appointment to be made are subject to the outcome of the Writ Petitions viz., W.P.(MD) Nos. 18481 to 18483 of 2017 and WMP(MD)Nos. 14917, 14919 and 14921 of 2017 pending on the files of Madurai Bench of Madras High Court relating to this recruitment and any other cases pending on the files of the Hon'ble High Court, Madras / Madurai Bench of the Madras High Court.
- f) **The Appointment and posting order will be issued by the Commissioner of Indian Medicine and Homoeopathy, Chennai-106 separately.**
