for the year 2014 - Published.

The Medical Services Recruitment Board is pleased to issue the list of provisionally selected candidates for the year 2014 for the post of **Physiotherapist Grade-II** to serve in the Government Medical Institutions in the state in the scale of pay of Rs.9300 – 34800 + Grade Pay Rs.4500. The selection is based on the Employment Registration seniority of the candidates in the Employment Exchange, duly observing the reservation policies of the Government.

As per the directions of the Madurai Bench of the Hon'ble High Court of Madras vide MP 2 of 2012 in W.P.(MD) No.4482 dated:29.06.2012, and WP(MD) No. 2259 of 2014 dated 11.02.2014, two posts of Physiotherapist Grade-II are kept vacant.

The selection list in respect of 2 (Two) vacancies, reserved for the Ex-Servicemen will be issued separately.

NOTE:

- a) If the candidate has wrongly furnished information or suppressed any information to the Medical Services Recruitment Board, the provisional selection is liable for cancellation.
- b) The appointment orders for the selected candidates will be issued by the Directorate of Medical and Rural Health Services through counselling.
- c) All the Provisionally selected candidates have to produce Physical Fitness certificate to the appointing authority at the time of joining. The differently abled candidates shall fulfill the norms as per rules and their fitness to serve as Pharmacists should be certified by the Medical Board.
- d) The reservation to the posts have been done as per the 200 point roster issued in G.O.Ms.No.65 P&AR Dept. Dated 27.05.2009 and duly taking into account of all subsequent instructions of the Government in this regard.
- e) The selection of candidates is purely provisional subject to the outcome of the W.Ps relating to this recruitment pending before the Hon'ble High Court of Judicature at Madras or at Madurai Bench of the Madras High Court.
- f) The provisional selection of candidate marked with (*) is withheld for want of additional particulars / documents / information to Medical Services Recruitment Board. The candidate is advised to furnish the details to the Medical Services Recruitment Board within 30 days of this notification, failing which, his/her selection will be cancelled without any further notice.
