ORDER:-

In the Government Order first read above, orders have been issued directing the Medical Services Recruitment Board to select 2159 Medical Officers (911 General (MBBS), 1163 Speciality and 85 Dental) temporarily. Based on the Government order, the Member Secretary, (i/c) Tamil Nadu Medical Services Recruitment Board has selected and sent proposal for issue of appointment orders for 56 Assistant Surgeons (Dental) (General) for which the Government is the appointing authority.

2. The Member Secretary, Medical Services Recruitment Board in his letter 4th read above has stated that one of the conditions for selection of candidates as per the notification was that the candidates should have a valid permanent registration of the Tamil Nadu Dental Council on or before the last date for on-line application i.e. on 28.4.2013. But, some of the candidates who were ineligible to apply had furnished wrong registration number in their on-line application and appeared in the written examination and were provisionally selected. On verification of candidates, it was found that they were ineligible to apply for the posts and they did not fulfill the condition stipulated in the notification, such candidates were not considered for selection in the final list. However, many number of such candidates who had applied for the post of Assistant Surgeons and Assistant Surgeons (Dental) and were not considered for selection have filed W.P.No.23948/2013 and a batch of similar cases.

3. The High Court of Madras in its interim order $2^{\rm nd}$ read above, has passed the following interim orders:-

"The petitioners have challenged the list of final selection dated:21.8.2013 for appointment of Assistant Surgeon (General) pursuant to the notification dated:31.3.2013 by the second respondent and sought for appointment of the petitioner as Assistant Surgeon. Since a number of cases have been filed and considering the public interest involved in a via-media this court pass the following orders without prejudice to the rights of the parties.

The respondents are directed to conduct the counseling for the petitioners and accommodate the petitioners by giving appointment orders in available vacancies. This order will also be covered for all appointments which are covered by the same notification. Ten days time is granted to the respondents to complete the exercise. It is made clear that the above order is passed subject to the result of the writ petitions without prejudice to the rights"

- 4. In pursuant of the interim orders passed by the Hon'ble High Court of Madras in W.P.No.23948/2013 and a batch of similar cases on 11.09.2013 and based on the opinion of the Additional Advocate General-V in the reference 3rd read above, the Member Secretary, Medical Services Recruitment Board has sent a list of 56 Assistant Surgeons(Dental)(General) candidates including one candidate covered under Registration issue and 19 Assistant Surgeons(Dental)(Speciality) candidates including two who are covered under Registration issue. The said three Medical Officers selected who are covered under the registration issue have to be appointed subject to the outcome of the W.P.No.23943/2013 and related batch cases pending in the High Court of Madras. The Member Secretary, Medical Services Recruitment Board has therefore, requested to issue necessary orders in this regard.
- 5. The Government have examined the proposal of the Member Secretary, Medical Services Recruitment Board and accept the same. Accordingly, the Government issues the following orders:-
 - To appoint the 56 selected Assistant Surgeons(Dental) (General) candidates by the Medical Services Recruitment Board mentioned in the Annexure I to this order including one who is covered under Registration issue in the sanctioned posts of existing vacancies in the directorates of Medical and Rural Health Services, Medical and Rural Health Services(ESI) and the Directorate of Medical Education temporarily.
 - ii) To appoint the 19 selected Assistant Surgeons(Dental) (Speciality) candidates by the Medical Services Recruitment Board mentioned in the Annexure –II to this order including two candidates who are covered under Registration issue, in the sanctioned posts of existing vacancies in the Directorate of Medical Education temporarily.
 - iii) The appointment of the three Assistant Surgeons (Dental) (General/Speciality) (who are covered under the registration issue) as per the interim orders of High Court of Madras dated:11.09.2013 in W.P.No.23948/2013 shall be subject to the outcome of the

W.P.No.23948/2013 and related batch cases pending in High Court of Madras.

iv) the Director of Medical and Rural Health Services, Director of Medical and Rural Health Services (ESI) and the Director of Medical Education is directed to issue necessary posting orders to the selected candidates following due procedures.
