### ORDER:

In the Government order first read above, the adhoc rules for the post of Technician in the Neuro Surgical Units and Electro Encephalographic Department has been framed which is applicable only to the post of Technician in the Neuro Surgical Unit and Electro Encephalographic Department of Government General Hospital, Chennai and the said rules have been amended in G.O.Ms.No.1639/ Education and Public Health, dated 29.07.1965 making this rules applicable to temporary posts of Technicians in the Neuro Surgical Units and Electro Encephalographic Department in the other Government Hospitals. The Board of Para Medical Education under the control of the Director of Medical Education has since conducted various Para Medical Courses in Government Medical Colleges. In order to provide employment opportunities to the persons who have undergone Para Medical Certificate Course and to appoint the trained personnel in the posts of Technician in the Neuro-Surgical Unit and Electro Encephalographic Department in Government Medical College Hospitals, the following amendments are issued to the existing rules.

The following Notification will be published in the <u>Tamil Nadu Government</u> Gazette:-

#### NOTIFICATION.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Adhoc rules published with the Health, Education and Local Administration Department Notification No. SRO A – 6244 of 1957, dated 11<sup>th</sup> September 1957, at page 1808 of part I of the Fort St. George Gazette dated 16<sup>th</sup> October 1957.

2) The amendments hereby made shall come into force from the date of issue of this order.

## AMENDMENTS.

In the said Rules,-

(1) for rule 5, the following rule shall be substituted.-

"No person shall be eligible for appointment to the post unless he/she possesses the following Qualification".

- (i) A pass in HSC with Science Subjects
  - (a) Physics, Chemistry, Botany and Zoology (or)
  - (b) Physics, Chemistry and Biology
- (ii) Must have passed the one year Certificate course in EEG/EMG conducted in Government Medical Institutions under the control of Director of Medical Education (or) in any other institution recognized by the State / Central Government.
- (2) in rule 7, after Proviso, the following Proviso shall be added, namely:-

"Provided further that on and from 1.06.1988, the monthly pay shall be calculated in the scale of pay Rs.950-20-1150-30-1500".

"Provided further that on and from 1.06.1996, the monthly pay shall be calculated in the scale of pay Rs.3050-75-3950-80-4590".

"Provided further that on and from 1.01.2006, the monthly pay shall be calculated in the scale of pay Rs.5200-20,200+GP 2400".

(3) After rule (7), the following shall be added:-

"8. Saving Clause: Nothing contained in these rules shall adversely affect any person holding the post as on date".
