ORDER:

In the Government order fourth read above, Government have issued orders permitting the Special Commissioner of Indian Medicine and Homeopathy, Chennai for starting of 2 ½ years Diploma in Integrated Pharmacy (DIP) course in the Indian System of Medicine (ISM) at Arginar Anna Government Hospital of Indian Medicine and Homoeopathy, Chennai and the Government Siddha Medical College at Palayamkottai, Tirunelveli District. Therefore it is imperative to include the new qualification of Diploma in Integrated Pharmacy course in the adhoc rule for the post of Pharmacist (Homoeopathy) as the Diploma in Integrated Pharmacy course comprises of the Systems of Siddha, Ayurveda, Unani and Homoeopathy.

NOTIFICATION.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following

amendments to the Adhoc rules for the post of Pharmacist (Homoeopathy), published with the Health and Family Welfare Department Notification No.SRO B 293/81 at pages 316-317 of Part III-Section 1(a) of the Tamil Nadu Government Gazette, dated the 8th July1981.

<u>AMENDMENT</u>

In the said Adhoc rules, in rule 5, for sub-rule (b), after clause (2) the following clause shall be added, namely –

" or

(3) Must have passed the Diploma in Integrated Pharmacy course conducted by the Government of Tamil Nadu."
