ORDER:

A number of advanced medical equipments are increasingly used in the medical field. In order to make efficient use of the technology, provided by the latest equipments, the Government have accorded permission to conduct the Para Medical Certificate Course in Electro Cardiogram / Treadmill Technician (Duration: One Year) in Government Medical teaching institutions and in King Institute of Preventive Medicine and Research, Guindy, Chennai to meet the need for trained man power both within the State and Outside vide Government Order 4th read above. The Electro Cardiogram Technician posts are available in Electro Cardiogram Department for appointment. To fill up the above posts by the candidates who have undergone Para Medical Certificate Course in Electro Cardiogram/ Treadmill Technician conducted in Government Medical Colleges and in King Institute of Preventive Medicine, Guindy, Chennai, the existing special rules in respect of the post of Technician in Electro Cardiogram Department have to be amended with regard to the qualification. The Director of Medical Education has sent amendment proposal regarding method of appointment and qualification to the post of Electro Cardiogram / Treadmill Technician.

- 2. The Government have examined in detail the proposal of the Director of Medical Education to amend the existing special rules for the post of Technician in Electro Cardiogram department and has decided to accept it.
- 3. The following appended notification will be published in the <u>Tamil Nadu</u> Government Gazette.

APPENDIX. NOTIFICATION.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Medical Subordinate Service (Section 21 in Volume III of the Tamil Nadu Services Manual 1970).

AMENDMENTS.

In the said Special Rules, in Part II, under "Branch IV General",-

(1) in rule 2, in sub-rule (a) under class III, for Category 4, Electro Cardiogram Technician and the entries relating thereto, the following shall be substituted, namely:-

> "Category -4 Electro Cardiogram Technician: (i) By direct recruitment; or

- (ii) By promotion from any other class or category in the Tamil Medical Subordinate Nadu Service: or
- (iii) By recruitment by transfer from any other service,
- (2) in Annexure II, under Class III, for category 4, Electro Cardiogram Technician and the entries relating thereto, the following shall be substituted, namely:-

"Category -4 Electro Cardiogram Technician: (1) By direct recruitment

(i) Must have passed PUC under old regulations; or

> A pass in Plus 2 course eliaibility with University course of study and

(ii) Must have passed one year certificate course in Electro Cardiogram or Treadmill Technician conducted by the Government of Tamil Nadu

- (2) By promotion from any other class or category in the Tamil Nadu Medical Subordinate Service or By recruitment by transfer from any other service
- (i) Must have completed SSLC under old regulation or a pass in SSLC [X standard] under new regulations, and
- (ii)Must have undergone training in a Government Institution recognised by the Government of Tamil Nadu or Government of India in the subject of operating and maintaining Electro Cardiogram apparatus for a period of not less than six months and should possess a certificate of proficiency in Electro Cardiogram Technique; or

Must have passed one year certificate course in Electro Cardiogram / Treadmill Technician conducted by the Government of Tamil Nadu."
