## ORDER:

In the G.O. first read above, orders have been issued for the constitution of Medical Services Recruitment Board to the effect that all direct recruitments under the control of the Directorates of Health and Family Welfare Department, made through Employment Exchange henceforth, will be under the purview of the Medical Services Recruitment Board.

- 2) In the G.O. second read above, the posts of Assistant Surgeon and Assistant Surgeon (Dental) which were under the purview of the Tamil Nadu Public Service Commission were brought outside the purview of the Tamil Nadu Public Service Commission. It was also ordered that the posts of Assistant Surgeon and Assistant Surgeon (Dental) shall be brought forthwith under the control of Medical Services Recruitment Board.
- 3) Consequent on the above orders, the following notification will be published in the <u>Tamil Nadu Government Gazette</u>.

## NOTIFICATION.

In exercise of the powers conferred by Article 318 and the proviso to clause (3) of Article 320 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Tamil Nadu Public Service Commission Regulations, 1954 (Volume-I of the Tamil Nadu Services Manual, 1987)

2. The amendment hereby made shall be deemed to have come into force on the 22<sup>nd</sup> July 2014.

#### AMENDMENT.

In the said Regulations, in Annexure I-A, under the heading "A.STATE SERVICES", after the entry "124. Principal, Professor, Lecturers, Tutors, Assistant Superintendent, Lady Physician, Medical Officer (Homeopathy) in the Tamil Nadu Medical Service whose services were regularised with effect from the date of their appointment as ordered in G.O.Ms.No.3, Indian Medicine and Homeopathy Department, dated 21-1-1988", the following entry shall be inserted, namely:-

"124. A. Assistant Surgeon and Assistant Surgeon (Dental) in the Tamil Nadu Medical Service".
