ORDER:

In the Government order sixth read above, the Government have issued an executive order to enable the candidates who have passed Higher Secondary without science subjects and possess CRA course qualification to participate in the recruitment process for the post of Dark Room Assistant by Medical Services Recruitment Board pending issue of amendment to the Special Rules for the Tamil Nadu Medical Subordinate Service to the educational qualification for the post of Dark Room Assistant.

2. Now, the Director of Medical Education in his letter seventh read above has forwarded the draft amendment to the Special Rules for Tamil Nadu Medical Subordinate Service for the post of Dark Room Assistant by including the qualification HSC without Science subjects for the 140 candidates who have passed prior to 2010-11 and have been permitted to undergo the Certified Radiological Assistant Course.

- 3. The Government examined the above proposal of the Director of Me Education in detail and has decided to accept it.

NOTIFICATION

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Special Rules for the Tamil Nadu Medical Subordinate Service (Section 21 in Volume III of the Tamil Nadu Services Manual, 1970)

The amendment hereby made shall be deemed to have come into force on and from 26th February 2021.

AMENDMENT

In the said Special Rules, in Part II, under the heading Branch IV - General, in Annexure-II, under Class II, for the entries in Column (2) against the entry "Category - 4 Dark Room Assistants in Column (1), for the existing first proviso under heading "By Direct Recruitment, or for special reasons, by recruitment by transfer from any other service" thereof the following proviso, shall be substituted

Provided that if candidates with the certificate of Dark Room Assistant are not available, then candidates with Certificate of Radiological Assistant of any Institution recognized by the State Government or Government of India, with or without science in Higher Secondary Course, shall be appointed.
