ORDER:

In the Government Order first read above, various categories of Unipurpose Health Workers were absorbed as Multipurpose Health Assistant and Multipurpose Health Supervisors for implementation of the Multipurpose Health Worker Scheme. The actual implementation of the Government Order came into effect on 04.11.1988.

2) In the Government Order second read above, adhoc rules for the posts of Multipurpose Health Workers (Notification-I) and Multi Purpose Health Supervisors (Notification-III) have been issued and the rules also came into force with effect from 04.11.1988.

3) In the Government Order third read above, the Government have reorganized the male component in which the post of Multipurpose Health Assistant and Multipurpose Health Supervisor were re-designated as Health Inspector Grade-II and Health Inspector Grade-I respectively. Accordingly the adhoc rules were also amended in the Government Order fourth read above.

- 4) In the Government Order fifth read above, amendments have been issued to the adhoc rules to change the nomenclature from Health Inspector Grade-II and Health Inspector Grade-I as Multipurpose Health Worker (Male) and Multipurpose Health Supervisor (Male), appointing authority, age, other qualification, method of appointment, transfer and posting and others.
- 5) In the Government Order sixth read above, orders have been issued authorizing the Director of Public Health and Preventive Medicine to approve the new guidelines and syllabus of the Multipurpose Health Worker (Male) / Health Inspector / Sanitary Inspector Course offered by Private Institution / Trust / Universities / Deemed Universities, adopt the new procedural requirement, if any, for applying the above said courses conducted by Private Institution / Trust / Universities / Deemed Universities including Gandhigram Rural Institute and to conduct the above examinations as Chairman Board of Examinations for the courses conducted by the above institutions.
- 6) In the Government Order seventh read above, amendments have been issued to the adhoc rules to change the nomenclature from Multipurpose Health Worker (Male) and Multipurpose Health Supervisor (Male) as Health Inspector Grade-II and Health Inspector Grade-I respectively.
- 7) In the letter eighth read above, the Director of Public Health and Preventive Medicine has requested amendment to rule 5(b)(1) of the Adhoc Rules for the post of Multipurpose Health Worker (Male) in Tamil Nadu Public Health Subordinate Service relating to educational qualification.
- 8) The following Notification will be published in the <u>Tamil Nadu Government</u> <u>Gazette.</u>

NOTIFICATION.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Rules published with the erstwhile Health, Indian Medicine and Homeopathy and Family Welfare Department Notification No.SRO B-301/89, published at pages 208-209 of Part III- Section 1 (b) of the <u>Tamil Nadu Government Gazette</u>, dated the 6th September, 1989, as subsequently amended.

2. The amendment hereby made shall be deemed to have come into force on 13th April, 2017.

AMENDMENT.

In the said Rules, in rule 5, in sub-rule (b), in the Table, for the entries in item (iii) under column (2) against the entry "By Direct Recruitment" in column (1) and for the entries in item (iv) under column (2) against the entry "By recruitment by transfer from Tamil Nadu Basic Service under the control of the Director of Public Health and Preventive Medicine" in column (1), the following entries shall respectively be, substituted, namely:-

"Must possess two years Multipurpose Health Worker (Male) / Health Inspector/ Sanitary Inspector Course Certificate granted by the Director of Public Health and Preventive Medicine: Provided that those who possess the one year Multipurpose Health Worker (Male) training course certificate granted by the Director of Public Health and Preventive Medicine conducted in the Government training centre or Institutions approved by the Director of Public Health and Preventive Medicine, prior to the introduction of the two years Multipurpose Health Worker (Male) / Health Inspector / Sanitary Inspector Course certificate granted by the Director of Public Health and Preventive Medicine, are also eligible for appointment to the said post."
