ORDER:-

In the Government Order first read above, among others 5% of the substantive vacancies in the cadre of Assistant Surgeon has been reserved for member of the service who were deputed for military duty and for non-service candidates who rendered military service in connection with Short Service Commission or Regular Service Commission. The said amendment to the Special Rule for Tamil Nadu Medical Service has been given effect from 05.08.2021.

2. In the letter second read above, the Medical Services Recruitment Board has requested the turns to be allotted to the said members in the 200 point communal roster in order to implement the reservation in the recruitment of Assistant Surgeon (General).

3. The Government after careful examination, direct the Medical Services Recruitment Board to follow the turn and rotation for Ex-servicemen specified in the Schedule-VII read with Section 27(C) of the Tamil Nadu Government Servants (Conditions of Service) Act, 2016 (TN Act No. 14 of 2016), (applicable to the post coming under Group-C Post) in selection to the post of Assistant Surgeons (Group-B Post) who have been deputed for military duty and non service candidates who have rendered military service in connection with the Short Service Commission or Regular Service Commission.

4. Necessary amendment to Special Rules for the Tamil Nadu Medical Service will be issued separately.
