## APPENDIX.

# NOTIFICATION.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendment to the Rules published with the Health and Family Welfare Department Notification S.R.O No.B12/89, at page 8 of part III – Section 1(b) of the Tamil Nadu Government Gazette, dated the 25th January 1989.

2. The amendment hereby made shall be deemed to have come into force on 01.09.2022.

### **AMENDMENT**

In the said Rules, in rule 5, in clause (b), to sub-clause(ii) the following proviso shall be inserted namely:-

"Provided that the persons with Diploma or Degree in Optometry conducted by a Government Medical College or any other institution recognized by the Directorate of Medical Education and Research and not passed the three months condensed Para Medical Ophthalmic Assistant Course shall also be eligible for selection to the said post subject to the condition that they should pass the said course at their own cost for appointment to the said post."
