In exercise of the powers conferred by the proviso to Article 309 of the  
Constitution of India, the Governor of Tamil Nadu hereby makes the following  
amendments to the Special Rules for the Tamil Nadu Medical Subordinate  
Services (Section 21 in Volume III of Tamil Nadu Service Manual, 2016)

#### AMENDMENTS

In the said Rules, in Part-II, under "Branch V - Miscellaneous", in  
ANNEXURE, in the tabular column, under the heading "Qualification" in column  
(2) against the entries "Category 13B Nursing Assistant, Grade-II" in column (1)  
thereof, -

- (i) in item (i), for the expression "26 years", the expression "32 years"  
shall be substituted;
- (ii) for the entries in item (ii), the following entries shall be substituted,  
namely:-  
"Must possess the Secondary School Leaving  
Certificate from recognized school"; and
- (iii) in item (iii), second proviso shall be omitted.
