## ORDER:

A number of advanced medical equipments are increasingly used in the medical field. In order to make efficient use of the technology provided by the latest equipments, the Government have accorded permission to conduct the Para Medical Certificate Course in Orthopaedic Technician (Duration: One Year) in Government Medical Teaching Institutions to meet the need for trained manpower both within the State and outside in the Government Order third read above. The Plaster Technician Grade-II posts are available in the Orthopaedic Department for appointment. To fill up the above posts by the candidates who have undergone Para Medical certificate course in Orthopaedic Technician conducted in Government Medical Colleges, the existing Special rules in respect of the post of Plaster Technician Grade-II have to be amended with regard to the qualification. The Director of Medical Education has sent amendment proposal regarding qualification to the post of Plaster Technician Grade-II.

- 2. The Government have examined in detail the proposal of the Director of Medical Education to amend the Special Rules for the post of Plaster Technician and has decided to accept it.
- 3. The following Notification will be published in the <u>Tamil Nadu Government Gazette</u>.

## NOTIFICATION.

In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Tamil Nadu hereby makes the following amendments to the Special Rules for the Tamil Nadu Medical Subordinate Service (Section 21 in volume III of the Tamil Nadu Services Manual, 1970).

# AMENDMENTS.

In the said Special Rules, in Part-II, under the heading "Branch IV General", in Annexure-II referred to in rule 7, under Class-III, under the heading "by direct recruitment", against Category 3 Plaster Technician Grade-II, the following entries shall be substituted, namely:-

- " (i) A pass in HSC (Academic) Examination with eligibility for University Course of study.
  - (ii) Must have passed one year Certificate Course in Orthopaedic Technician conducted at Tamil Nadu Government Medical Institutions."
