ORDER:-

In the G.O first read above, orders have been issued for the constitution of Medical Services Recruitment Board exclusively for Health and Family Welfare Department so as to centralize the mode of direct recruitment to all categories existing in Health and Family Welfare Department, except those that are coming under the purview of Tamil Nadu Pubic Services Commission.

2. In the G.O. second read above, Rules of Procedure of the Medical Services Recruitment Board for recruitment to various categories have been issued.

3. In the Government Letter third read above, the Medical Services Recruitment Board has been permitted to recruit the candidates in Tamil Nadu Medical Service from the reserve list by following section 3 (u) of Tamil Nadu Government Servants (Conditions of Service) Act 2016 (Tamil Nadu Act 14 of 2016), instead of rule 7 of the Rule of Procedure of the Medical Services Recruitment Board, 2013.

4. Now the Chairman, Medical Services Recruitment Board has requested the Government to issue suitable amendment to the Government order in the second read above in respect of the reserve list by duly substituting with section 3(u) of Tamil Nadu Government Servants (Conditions of Service) Act 2016 (Tamil Nadu Act 14 of 2016).

5. The Government after careful examination, of the proposal of the Chairman, Medical Services Recruitment Board (MRB), it has been decided to amend the Rules of Procedure of the Medical Services Recruitment Board, 2013. Accordingly, the following amendment be issued to the Rules of Procedure of the Medical Service Board annexed in the Government order 2nd read above.

AMENDMENT

In the said Rules, for rule 7, the following shall be substituted: -

"7. Reserve list:

In respect of open advertisements, the Medical Services Recruitment Board shall prepare a list which contains not less than twenty five per cent of the candidates of each reservation group including General Turn in the regular list and shall be in force until the regular list is drawn up subsequently."
