NOTE:

- The candidates have been provisionally selected based on the marks scored by them in the computer based examination held on 23.03.2025, verification of the mandated documents, and communal rotation etc. as per the existing orders of the Government of Tamil Nadu. In case where the marks obtained by two or more candidates are equal, the rank among them is decided based on the date of birth.
- As no eligible PSTM candidate is available for notified vacancies, the eligible general candidate of the respective category has been provisionally selected.

- c) No eligible candidate is available for 1 vacancy reserved for DAP – (BC-G-SLD) category and hence the same has been carried forward as backlog vacancy.
- d) The selection is purely provisional. The provisional selection and consequent appointment are subject to the outcome of the result of any writ petitions/ writ appeals pending on the file of the Hon'ble High Court of Madras / Madurai Bench of the Madras High Court.
