Note:-

1. As no eligible Ex-Servicemen candidates are available, the available general candidates of the respective communal category have been provisionally selected as per provision in 27(c) of Tamil Nadu Government Servant (Conditions of Service) Act 2016.
2. 2 vacancies in respect of DAP under GT (G DAP) – 1, MBC (G DAP)– 1 category among the notified vacancies have been carried forward as Backlog vacancy due to non – availability candidates.
  - a) The reservation to the posts has been made as per section 27 of Tamil Nadu Government Servants (Conditions of service) Act, 2016.
  - b) The appointment and posting orders will be issued separately by the appointing authority.
3. As no eligible PSTM candidates are available for the notified vacancies, eligible general candidates of respective category have been considered.
4. The selection is purely provisional. The provisional selection and consequent appointment are subject to the outcome of the result of any writ petitions/ writ appeals pending on the file of the Hon'ble High Court of Madras / Madurai Bench of the Madras High Court.
