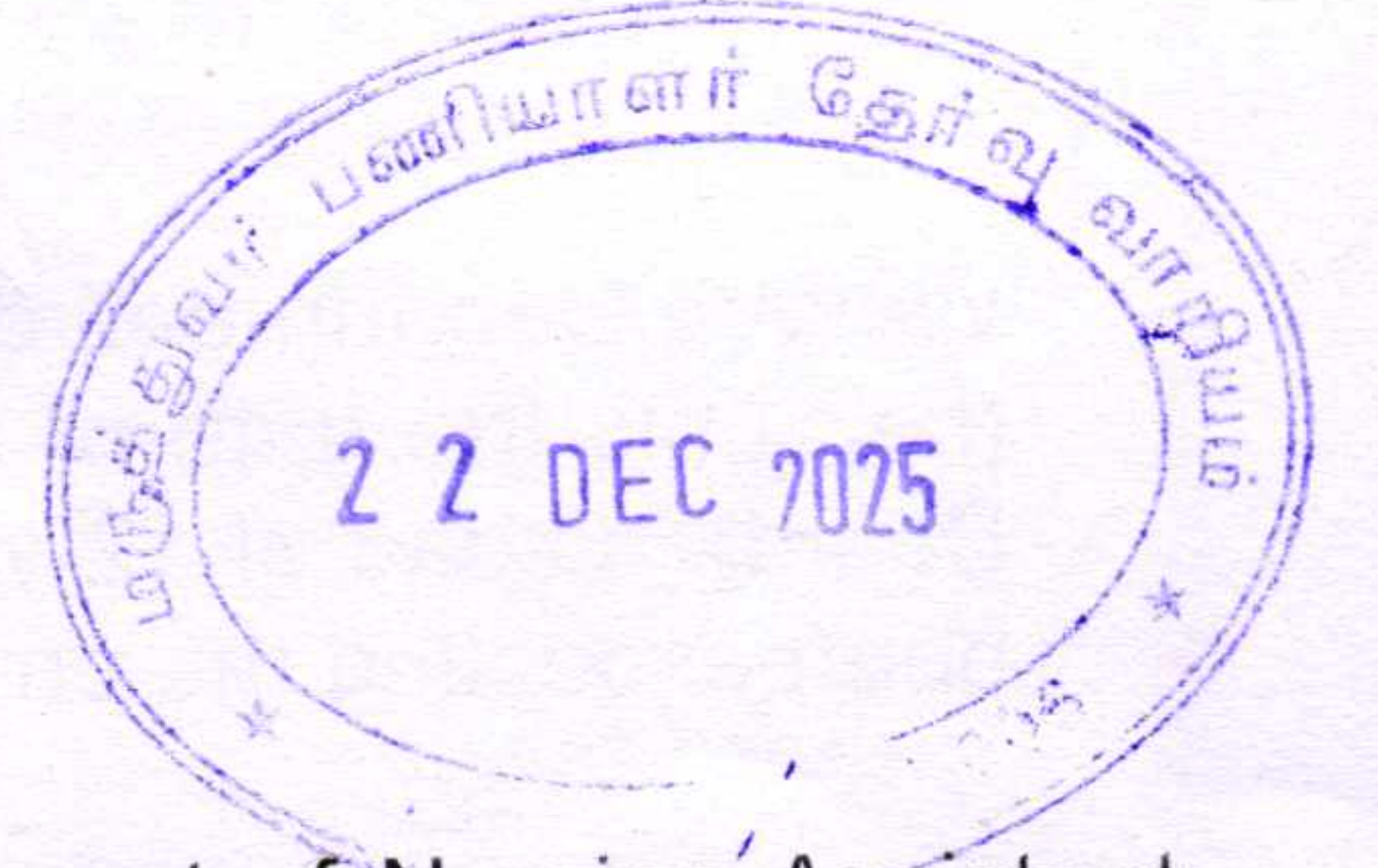




ABSTRACT



Tamil Nadu Medical Subordinate Service – Filling up of the post of Nursing Assistant Grade-II by Direct Recruitment through Medical Services Recruitment Board – Age Concession – Amendment – Orders – Issued.

G.O.(Ms).No.77, Health and Family Welfare Department, dated 14.03.2024

ORDER:-

In the Government order first read above, the Government, among others, have ordered as follows: -

“...5(ii) in the above said notification, preference in selection must be given to those candidates who have passed Xth standard and possess certificate for having successfully completed the training course for Nursing Assistant in any of the Government Medical Institutions in the State prior to the issue of Government order second read above and whose employment opportunity was affected due to the ethics imposed in the above said Government order, duly following communal rotation and relaxing maximum 12 years of age in respect of age criteria to whomever required for this recruitment alone, as a one-time measure.”

2. In this connection, the 1st method of appointment (Recruitment by transfer) for the post of Nursing Assistant Grade-II have already been made by the Head of Departments up to the date of issue of G.O.(Ms).No.325, Health and Family Welfare Department, dated 20.11.2012 and the second method of appointment (by direct recruitment) is pending to be made by the Medical Services Recruitment Board. Further, 12 years of age concession have been granted to the candidates to whomsoever required in of G.O.(Ms).No.77, Health and Family Welfare Department, dated 14.03.2024. Now, nearly two years have been passed after issue of the above said Government Order. Hence, an additional two years of relaxation may also be required to the above said candidates.

3. The Government have examined the issue in detail and it has been decided to extend the age concession from 12 to 14 years or until the date of Notification issued by the Medical Services Recruitment Board, by issuing an amendment to the Government Order read above. Accordingly, the Government do and hereby direct that the following amendment be issued to G.O.(Ms).No.77, Health and Family

Welfare Department, dated 14.03.2024 by extending the age concession for 14 years (i.e., until the date of notification to be issued by the Medical Services Recruitment Board) instead of 12 years, so as to enable to give natural justice for those who had been expecting the employment opportunities for the past 14 years.

AMENDMENT

"For the sub-para (ii) of para 5 mentioned in G.O.(Ms).No.77, Health and Family Welfare Department, dated 14.03.2024, the following para shall be substituted."

- ii. *"in the above said Notification, preference in selection must be given to those candidates who have passed X standard and possess certificate for having successfully completed the training course for Nursing Assistant in any of the Government Medical Institutions in the State prior to the issue of Government order second read above and whose employment opportunity was affected due to the ethics imposed in the above said Government order, duly following communal rotation and relaxing maximum 14 years of age or until the date of notification to be issued by the Medical Services Recruitment Board in respect of age criteria to whomever required for this recruitment alone, as a one-time measure."*
