NOTICE OF DELETION OF CANDIDATURE FOR THE POST OF ASSISTANT SURGEON (GENERAL) 2014

The Medical Services Recruitment Board has conducted competitive examination for the post of Assistant Surgeon (General) on 12.10.2014. The certificate verification for the eligible candidates was conducted from 03.11.2014 to 18.11.2014, 24.11.2014 and from 2.12.2014 to 4.12.2014 and 11.12.2014.

During the certificate verification it has been noticed that the below mentioned candidates have registered their names in the Tamil Nadu Medical Council beyond 10.8.2014

As per condition (iii) under heading 5-B – EDUCATIONAL QUALIFICATION - of the Detailed Notification of MRB, "candidates should have registered their names in Tamil Nadu Medical Council before the date of notification. The date of notification was 10.8.2014. The persons who have registered their MBBS degree after 10-8-2014 in the Tamil Nadu Medical Council are ineligible to apply and appear for the Assistant Surgeon Examination. Further, in the online application, the application of applicants who had registered beyond 10.8.2014 were rejected.

Despite the specific instructions, the candidates mentioned below, have wilfully furnished wrong and misleading information in their on-line application and have appeared for the written examination. The details of Registration No. and Date furnished in the online application and the details furnished at the time of certificate verification are furnished below.
