a) One post is reserved pending outcome of Review Applications (S.R.No.24180 of 2018, S.R.No.24179 of 2018, S.R.No.24181 of 2018, S.R.No.24164 of 2018) filed in the orders of the Hon'ble High Court of Madras in W.P.No.13032, 12975, 13335 and 13267 of 2013 dated.13.02.2018 and the three other petitioners in W.P.No. 13032, 12975 and 13335 of 2013 have been provisionally selected in the current selection.

Another post is reserved pending outcome of Writ Appeal (W.A.S.R.No.6614 of 2018) filed against orders of the Hon'ble High Court of Madras in W.P.No.28342 of 2017 dated.10.11.2017.

b) Any claims preferred by the candidates should reach within 10 days from the date of issue of related provisional selection notification and appeals if any received after 10 days will not be entertained.

c) The Differently Abled candidates shall fulfill the norms as per G.O.(Ms).No.03, Health and Family Welfare (C2) Department dated 06.01.2016.

d) The reservation to the posts have been done as per section 27 of Tamil Nadu Government Servants (Conditions of service) Act, 2016.

e) The selection is purely provisional subject to the outcome of the Writ Petitions in W.P.No.3556/2018 and W.P.No.3557/2018 relating to this recruitment, and any other writ petitions / writ appeals pending on the files of the Hon'ble High Court of Madras / Madurai Bench of the Madras High Court.

f) The appointment and posting orders will be issued separately by the appointing authorities concerned.
