<b>a.</b> Evidence of Date of Birth (Birth Certificate/SSLC / HSC)
<b>b.</b> Evidence and Mark sheet of Educational qualification (SSLC,HSC,DRA / CRA / Diploma in Radio Diagnosis / Diploma in Radio Therapy).Certificate / Diploma should be obtained from a Government or Government recognised Institution. If the candidate have studied in Central Government recognised institution, the applicant shall produce evidence for the same.
<b>c.</b> Evidence of Tamil qualification ( <i>viz.</i> , SSLC / HSC / Certificate for having passed the second class Language Test (Full Test) in Tamil conducted by the Tamil Nadu Public Service Commission).
<b>d.</b> Community certificate from the competent authority (Permanent Community Certificate)
<b>e.</b> Certificate of character and conduct issued by Group A or Group B Officer on or after issue of the current notification.
<b>f.</b> Certificate of character and conduct issued by the Head of the Institution in which he / she last studied.
<b>g.</b> Differently abled certificate issued by the competent authority (if applicable) as in Annexure 7A & 7B of this Notification.
<b>h.</b> No Objection Certificate from the Appointing Authority concerned (if applicable) as in Annexure 5 of this Notification.
<b>i.</b> An undertaking and Declaration to be submitted as in para 12A and 12B of this notification
<b>j.</b> Two (2) passport size colour photograph (that was used to scan and uploaded in the online application) (with name and application number on the reverse).
<b>k.</b> Any one of the photo ID Card issued by a Government Authority (other than PAN card), depicting the Address for communication or permanent Address furnished in the online application.
<b>l.</b> Challan copy (or) proof of payment of Exam fee already paid (either through on-line or off-line – Indian Bank Branch).
<b>m.</b> Destitute widow certificate as per Annexure – 9 (if applicable).
<b>n.</b> In respect of Ex-Servicemen they have to produce the Discharge Certificate, PPO No., in case if he is already Discharged. If the candidate is a serving personnel to be discharged within one year from the last date of receipt of the application of this notification, he has to produce An undertaking given by the candidate in Annexure 8A & Form of Certificate for serving personnel in Annexure 8B of this notification (if applicable).
