**NOTICE OF DELETION OF CANDIDATURE FOR THE POST OF
ASSISTANT SURGEON (GENERAL) 2014**

The Medical Services Recruitment Board has conducted competitive examination for the post of Assistant Surgeon (General) on 12.10.2014. The certificate verification for the eligible candidates was conducted from 03.11.2014 to 18.11.2014; 24.11.2014 and from 02.12.2014 to 04.12.2014 and 11.12.2014.

During the certificate verification it has been noticed that eleven number of candidates mentioned in the Annexure to the proceedings have appeared for the competitive examination.

As per the Annexure-5 of the Detailed Instructions to the candidates, *“persons who are in the service of the Indian Union or a State in India or in the employment of Local Bodies or Universities or Quasi Government organisations constituted under the authority of the Government of India or of a State in India whether in regular service or in a temporary service need not send their applications through their Head of Department or Employer. Instead they may directly apply to the*

Board duly informing their Employer in writing that they are applying for the particular recruitment and with the condition that they should produce “No Objection Certificate” as in Annexure-5 of the detailed notification from their Appointing Authorities concerned.”

However the candidates in the annexure did not produce “No Objection Certificate” in the prescribed form from their Appointing Authority, during certificate verification or subsequently. Therefore, the Board hereby orders removal of their candidature for the above said post.
